



GENERAL RELEASE AND WAIVER

For everyone's safety, we ask that you do not attend if you are feeling sick or experiencing symptoms of any illness or have been exposed to anyone experiencing symptoms of any illness.

In consideration of the opportunity to voluntarily enter this area to attend and/or participate in this event located at Moda Center (1 N Center Court St, Portland OR 97227) on JULY 26, 2026 from 9:00am to 12:00pm. and/or any related activity, including without limitation, physical activities and use of related equipment, whether provided by the event venue or a Released Party (collectively, this "Event"), you, the undersigned, on behalf of yourself, your guests or other individuals in your party, and, if applicable, in your capacity as parent/legal guardian hereby represent and warrant that you are over the age of 18 and, if you are attending with one or more guest or minor children (each a "Minor"), that you are the parent/legal guardian of any such Minor or you have obtained written consent from such Minor's parent/legal guardian or guest to sign to attend this Event and act on their behalf, which includes without limitation acceptance of all the provisions of this General Release and Waiver ("Release"), acknowledgement and receipt of which is confirmed upon your acknowledgement and agreement to this Release and/or your physical entry into this Event, including the venue and parking facilities and all surrounding areas (collectively, the "Location"), regardless of whether you, your guest(s), or other individual, or a Minor participate in any manner, you hereby, on behalf of yourself, your guests or other individuals in your party, and, if applicable, any Minor attending with you (individually and collectively with each such guest and Minor, referred to herein as "you", "your" or "myself") acknowledge and agree to the following:

1. You warrant that you are fully aware of and expressly assume all inherent risks in attending and/or participating in any manner at this Event, including any related activity, and hereby expressly release, waive, discharge and hold harmless Portland Trail Blazers LLC, Rip City Management LLC, Rip City League, the National Basketball Association, the Location venue (and its owner entity), and each of their respective parent, subsidiaries, agencies, affiliates, directors, officers, employees, volunteers, agents and designees (collectively, the "Released Parties"), from any and all liability to yourself and any accompanying Minor, and to your and such Minor's respective conservators, guardians or other legal representatives, assigns, heirs and next of kin for any and all claims, suits, causes of action, demands, losses or damages including but not limited to claims for any injury, illness, death, or damage to person or property, relating to or arising out of your entry at the Location, attendance and/or participation in the Event or activities, including but not limited to, claims arising out of or related to the construction, use, maintenance or operation of the Event, this Location and/or any equipment, merchandise or products provided or used during this Event, or damages caused or alleged to be caused, in whole or in part, by the negligence of any Released Party.

2. You understand that your participation in Activities at any Location is done on a purely voluntary basis. You acknowledge that you have been provided the opportunity to inspect the equipment related to the Activities at the Location and either you have done so or will do so prior to participating. You also hereby agree to indemnify and hold harmless the Released Parties from any claim or demand on account of illness, injury or damage that another participant may suffer as a result of your participation in Activities, and all social and economic losses in connection thereto. You understand that this release, waiver and agreement to indemnify and hold harmless includes, but is not limited to, damages which are caused, or alleged to be caused, in whole or in part by the negligence of the Released Parties. You agree to accept and abide by any applicable PTB, RCM and/or venue rules, policies and procedures related to the Location and/or execution of this Event ("Rules"). P T B , RCM, and venue management reserve the right to refuse admittance, eject and/or revoke the right of any person to enter or remain in the Location who does not comply with any of the Rules, or exhibits or engages in a disruptive, indecent, offensive, illegal, inappropriate or destructive manner (including if such actions involve another attendee or excessive drinking) at any time during this Event.

3. You authorize and give full permission to each Released Party and grant the irrevocable right to use, without further notification, authorization or compensation to you or anyone on your behalf, your name, image, likeness, voice (collectively, "Likeness"), as well as any photographs, videotapes, motion pictures, recordings, and/or other record (or any combination or excerpt thereof) captured during the Event, in any and all media, whether now known or hereafter to become known, worldwide and in perpetuity, for purposes of entertainment, illusion, promotion, art, publicity, advertising and/or trade use. Further, you understand, acknowledge, and agree that any photograph, videotape, recording or other record submitted to or created by the Released Parties which contains your or a Minor's Likeness shall become the sole property of the Released Parties, and as such may be used in the same manner by a designee of one or more of the Released Parties. Please be aware that persons attending this Event may also take photographs in which you or a Minor may be visible, and that none of the Event staff nor Released Parties have the authority or control over such persons use and therefore are not liable to you nor any Minor should any Photo containing your or a Minor's Likeness be published in any manner or form of media, including but not limited to social media.

4. By signing this Release and/or attending or participating in this Event, you understand, acknowledge, and agree that (i) you have read and fully understand the above agreement, including the rights you are giving up as provided herein, (ii) you have the right to participate in this Event and that such participation will not reflect badly on the Released parties; (iii) that you are over the age of 18 and/or if you are signing on behalf of your guests or other individuals in your party, or, if applicable, a minor person, that you are such minor's parent/legal guardian or have written consent from such parent/legal guardian or guest to sign, (iv) the terms of this Release shall apply to your participation in any manner at any Location throughout the entire Event, and (v) you are voluntarily choosing to enter the Location and participate in this Event and the related activities, and (vi) you have full authority to execute this Release and do so with full knowledge of the facts and circumstances surrounding the Event, activities and the rights that you are granting herein.

You have read and fully understand the above agreement and also understand that by checking the box you have given up substantial rights. You understand, acknowledge and agree that the terms of this General Release and Waiver agreement shall apply to your participation in any Activity at the Location until such time as you sign a new one. You acknowledge that you will be voluntarily acknowledging and agreeing to this Release and Waiver, which will be made a part of this agreement, and further acknowledge and agree that such acknowledgement will constitute your agreement to the above provisions regardless of the fact that your acknowledgement may be on a separate page.
